Mr. Pedone expressed his gratitude to Mr. Gustafson, the administration, and the School Scheduling Committee for all the time spent on putting together the high school schedule. Mr. Pedone wanted to know what the next steps were to move forward with scheduling changes.

Mr. Fournier shared with the School Committee that the presentation the Committee was seeing tonight was going to be shared with teaching staff. The next steps would be to revise class selection sheets for all departments along with modifications to a few of the current West Boylston Public Schools policies along with curriculum preparations.

Mr. Ponticelli expressed concerns over teacher availability on offering more class selections. Mr. Fournier had shared that after looking over current class selections there were some teachers teaching the same classes. Mr. Fournier furthermore shared each teacher has the ability to teach 30 instructional periods.

Ms. Breen expressed that she was "glad West Boylston High School is here with this new schedule". A positive approach will be needed to make a successful transition for students and staff. Ms. Breen expressed that this new schedule has the potential for positive outcomes on AP scores along with MCAS scores in the future.
