## Major Edwards Elementary School Report May 2024 School Committee Meeting

This month at Major Edwards, much of the focus has been on completing the MCAS assessments in the areas of Math and Science / Technology in Grades 3-5 along with the completion of the end-of-year student assessments. Our students have continued to give their best on the assessments and we look forward to seeing the progress made by students over the course of the year.

This month we have two professional development days planned for teachers. This past Friday, teachers spent time learning about the effectiveness of Math Talks led by our Math Interventionist, Rose DiBenedetto, and classroom teachers Kelly Connors, Renee Brancaleone, and Liz Lemay. Additional time was spent on coteaching, where our 2nd Grade teachers, Ali Johnston and Jen Kallberg along with some of our 3rd Grade teachers, Christine Stratton and Christina Franklin, discussed how the implementation of the co-teaching model has gone in their prospective classrooms. It was great to hear some of the different strategies and methods that have been utilized with students to help increase their effectiveness in teaching in an inclusive classroom.

On May 17th, teachers will meet in grade level teams to meet with administration, specialists, and support staff to begin formulating the class lists for the 2024-2025 school year. Additionally, teachers will take time to meet with our Title 1 teachers, Mrs. Gangai and Sharon Bokankowitz to discuss student progress in literacy and determine where support is still needed as students head to summer and we begin thinking about support for next year in literacy.

This past Friday, students met for a community meeting that was focused on the theme of acceptance. Our 3rd grade students led a presentation where they read a story about acceptance, defined acceptance, and then shared unique facts about themselves to help the other grades learn what it means to be accepting to their classmates and school community. Next, selected students received an acceptance award from each classroom who the teachers felt have modeled acceptance the best in their classrooms. Later, the 5th Grade sang a song about reading and we had a special visit from two goats, Maverick and Goose that received kisses from the principal.

Lastly, this week the PTA planned an incredible week of celebration for our teachers during the Teacher Appreciation week. We would like to take a moment to thank all of our teachers at Major Edwards for their continued commitment to our students and dedication to teaching them each and every day. We would also like to give a special thanks to Jacqueline Leonardo and the many PTA members for all they have done to provide teachers with treats, donations, and ample appreciation for all that the teachers do throughout the school year. The middle high school was pleased to receive a letter from the New England Association of Schools and Colleges (NEASC) notifying us that we have been awarded continued accreditations. The Commission on Public Schools reviewed the First Report of Progress and Planning of West Boylston Middle/High School and voted to award the school continued Accreditation in New England Association of Schools and Colleges.

### **FY 25 Budget Update**

At their April 3rd meeting, the West Boylston Select Board voted to support the inclusion of a Proposition 2 ½ override at the May 20th Town Meeting. The proposed override will also be on the June 4th town election ballot. The West Boylston School Committee followed suit at the April 10th school committee meeting voting 5-0 to endorse the process. Planning continues as the district has submitted five-year projections to the Town Administration. The compiled projections are based on the average historical annual increases over the past decade, in tandem with estimated operating expenses for the next five years.

The West Boylston Finance Committee will host an educational forum on Monday, May 13 at 6:00 to discuss historical revenue and expense trends in West Boylston as well as the challenges presented in the FY25 Budget, including options to address them, both now and in the coming years.

Additionally, there is little doubt that referenced one million dollar deficit during the March budget presentation was concerning, however a few vital points should be highlighted:

- 1. The deficit was not created by fiscal mismanagement. The deficit impacting the District this budget season is also impacting many communities throughout the State was created by the following.
  - o School Districts budgets increasing by at least 4-5%
  - o ESSER grants being phased out
  - o Flat student enrollment impacting Chapter 70 funding
  - o Low per pupil inflation growth of 1.13%
  - o Reduction in Low- Income students (down 7,000)
  - Average Municipal Revenue Growth Factors increase of only 4.35%
- 2. The District can manage the deficit for FY 25 by heavily relying upon projected sources of revenue and reconfiguring existing programming and priorities. Although, the fiscal outlook for FY 26 is dire at this point.
- 3. The District is legally responsible to provide special education services for students with disabilities from ages 3-22. Services include instructional and behavioral support and a wide array of therapies. The District currently has 13 students receiving their education out of district. The average tuition for out of district placements is \$178,900 with transportation averaging \$45,880. These costs are uncontrolled and unpredictable
- 4. Sub Separate programs have been created at all levels to minimize the number of West Boylston students enrolled in out of district placements, including the expansion of the PASS program at Major Edwards, which expands to two classrooms next year.

The District's continued reliance on anticipated sources of revenue, with the grim fiscal projections in Massachusetts and the uncertainty on the federal level remains a source of concern. The District does not believe a "reduction in force" is necessary this fiscal year. We will continue our communication and collaboration with the Town with the continued goal of providing quality education offerings for all students.

### Massachusetts School Building Authority /Statement of Interest

A Statement of Interest was successfully submitted to the Massachusetts School Building Authority on March 13, 2024. The submission included detailed information related to the current state of the Middle High School facilities, including specifics related to HVAC, plumbing, windows, roof, auditorium, cafeteria, science labs, enrollment projections and ADA compliance concerns. The 2022 Colliers Project Leaders Facilities Assessment and the 2022 Town of West Boylston American with Disabilities Act Self Evaluation and Transition Plan were submitted as supporting documents.

The information provided in the SOI will play an important role in helping the MSBA understand the needs at the Middle High School and to decide whether to move forward with the district for further assessment of the facility. Once an SOI has been submitted and reviewed, the MSBA will work with districts to validate the deficiencies identified in the SOI and, if appropriate, collaborate on potential solutions. The MSBA will notify districts of any actions necessary during the due diligence period; after all SOIs are on file and the filing period has closed. A senior study may also be conducted as was the case with 2023's SOI submission.

The MSBA follows the steps below prior districts prior to extending invitations to enter the "eligibility period."

### 1. Review SOI submissions for completeness:

Once the SOI system has closed, MSBA staff review each submission to confirm that all required materials have been received. The MSBA works with districts throughout the filing period to ensure that the SOI is complete.

### 2. Review each SOI submission and accompanying documents for content:

Once an SOI is determined to be complete, MSBA staff review the information and any additional documents submitted by the district. MSBA staff then compile the data necessary to assess SOIs filed in that calendar year that may be categorized as the most urgent and needy.

Determining the most urgent and needy SOIs relies on many different data sources. MSBA staff use over 50 data points that include the SOI, the MSBA project management system, the MSBA's enrollment tool, the MSBA's 2016 School Survey, and information from the Department of Elementary and Secondary Education ("DESE"). There are many factors that can impact the assessment of urgency and need in an SOI, such as increasing enrollment, overcrowding, building condition, general environment, and program deficiencies. As such, it is important to assemble as much data as possible so that staff may gain as complete of a picture of the submitted SOI as possible.

Due to the volume of SOIs submitted for the Core Program, the MSBA requests that each district identifies a Priority SOI for consideration when filing more than one in a given year. This enables the district and the MSBA to focus financial and staff resources on completing a project and ensures an opportunity for a grant for as many districts as possible. Additionally, this narrows down the cohort of potential projects if districts have submitted multiple schools within the district for consideration.

With their focus on each district's identified Priority SOI, MSBA staff then look at this smaller cohort of submitted SOIs to assess urgency and need, focusing on:

- The 2016 School Survey rating of building condition;
- The 2016 School Survey rating of general environment;
- The previous or ongoing Core Program project activity with the MSBA; and,
- Section 8 of the MSBA's statute.

Consideration of these factors produces a smaller subset of the Priority SOIs that appear to be more urgent and needy than the other SOIs submitted that year. With this assessment, a group of SOIs are identified for further consideration. This further review may or may not require a senior study visit. If the MSBA is familiar with the school facility identified in the SOI or if the facility has already received a senior study visit within the previous two or three years, a senior study visit may not be needed for the SOI. The MSBA may choose to re-visit a school within this two or three-year window if the SOI contains new information since the last visit.

### 3. Conduct Senior Study Visits, if required:

If MSBA staff determine that a <u>Senior Study visit</u> is needed to complete the due diligence process, MSBA staff, accompanied by a technical consultant, will visit the SOI facility. The MSBA may conduct facility visits either virtually, in-person or a combination of virtual and in-person. The MSBA may request the use of alternative technology to complete the visits such as virtual meetings, drones, district-supplied recordings or other means.

Depending upon the method used, the senior study visit may be conducted in two parts, holding the meeting and the facility tour at different times and days.

The Senior Study visit lasts approximately two hours and is an opportunity for the MSBA to further understand the issues identified in the district's SOI. MSBA staff request that the district have someone familiar with the facility and systems present, someone familiar with the financial readiness of the district, as well as someone who is familiar with the curriculum as it relates to the programs offered. The district is requested to provide a copy of the school's floor plans (emergency/evacuation plans are sufficient) ahead of the MSBA's visit. The Senior Study visit starts with a meeting to review the SOI and the MSBA process and to hear district concerns. The discussion is followed by a tour of the main areas of the school, as well as typical general classrooms and specialty spaces.

Depending upon the number of senior study visits that are required, this phase can take approximately eight to ten weeks, with visits typically scheduled from August through October. This timeframe may vary.

### 4. Recommend SOIs for Invitation into Eligibility Period:

Once the content review and senior study visits have been completed, MSBA staff once again review the factors that can impact the assessment of urgency and need in an SOI (e.g., increasing enrollment, evidence of overcrowding, building condition, general environment and program deficiencies), to understand the total impact of all of the factors on the overall need expressed in the SOI. As the number of invitations that the MSBA can issue varies each year and the number of SOIs received each year exceeds the MSBA's annual cap expenditure, MSBA staff compare the SOIs that were selected for further review to each other to determine a degree of urgency and need, ranging from minor to major, for each of the SOIs.

MSBA staff then provide their findings to the <u>Chief Executive Officer</u>, <u>Executive Director/Deputy Chief Executive Officer</u> and the MSBA's <u>Facilities Assessment Subcommittee</u>. Recommendations are then presented to the MSBA Board of Directors and the Board of Directors vote to invite districts into the Eligibility Period.
